# Terms and Conditions for "Win 100,000 Kris Flyer miles with AXS" ("Promotion")

The Promotion is organised by AXS Pte Ltd ("AXS").

# **ELIGIBILITY:**

- 1. This Promotion is open to all existing AXS customers, who make Qualifying Transaction (as defined in Clause 6) on Participating Channels (as defined in Clause 4) ("Eligible Customer").
- 2. Employees of AXS, employees of vendors, advertising agencies of AXS are not eligible to participate in the Promotion.
