

## **Terms & Conditions of "AXS Christmas Advent Campaign" ("Promotion")**

1. This Promotion is open to all AXS customers on version 8.5 and above of the AXS m-Station mobile app, who are logged in via their social login. ("Eligible Customer")
2. The Promotion will run from 20 December 2025, 9am to 24 December 2025, 11.59pm ("Promotion Period").
3. Sixty (60) Vouchers will be released between 9am to 11.59pm daily during the Promotion Period (e.g on 20 December, between 9am – 11.59pm). ("Promotion Day")
4. Each Eligible Customer will be awarded one (1) \$5 AXS Voucher only during the Promotion Period to offset their bill payment ("Voucher"). To receive the Voucher, the Eligible Customer must claim the voucher within a Promotion Day.
5. AXS reserves the right to partially or completely cancel, terminate or suspend the Promotion for any reason without any liability whatsoever.
6. AXS reserves the right at any time to amend or delete these Terms and/or any of the instructions or explanations at its sole discretion without prior notice. Any such changes shall be binding and will take effect immediately upon such amendment, change or deletion. Participation in this Promotion shall constitute acceptance of these Terms and any amendment(s) thereof.
7. In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotional materials relating to the Promotion, these terms and conditions shall prevail.

AXS shall not be liable to the Eligible Customer for any loss or damage or expenses arising in connection with the Promotion, including without limitation, any error in computing any draw chances, any technical hardware or software breakdown or malfunction or defects in any computer/electronic system or equipment, failed, delayed or incorrect transaction, or lost or unavailable network connections, and any notice that is misdirected or lost in post, which may affect any Eligible Customers' eligibility in the Promotion.
9. Notwithstanding anything herein, AXS has the absolute discretion to determine the eligibility of any person to participate in the Promotion or receive the Voucher.
10. AXS's decision on all matters relating to or in connection with the Promotion is final and binding on all Eligible Customers. No further correspondence regarding the Promotion, these Terms or any decision made by AXS in connection therewith and/or the results will be entertained.
11. AXS reserves its absolute right to determine an outcome and act as it deems fit in any dispute and/or issues relating thereto.
12. These terms and conditions are governed by Singapore law and the Eligible Customers agree to submit to the exclusive jurisdiction of the Singapore Courts.

A person who is not a party to these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions and notwithstanding any terms herein, the consent of any third party is not required for any variation (including any release or compromise of any liability) or termination of the Promotion.
